In the event that the City asserts that some documents are only available in paper form, I ask for the opportunity to examine such documents in person. Regardless, I ask to be contacted explaining charges before any actions incurring costs beyond \$100.00.

If you find that this request is unclear in any way please contact me immediately so I can clarify the request or otherwise expedite your efforts to comply with all relevant deadlines and other requirements in the Michigan FOIA.
